The U.S. government has initiated a process, called the incentive auction, which will reallocate a still unknown amount of UHF TV band spectrum in order to accommodate demands for mobile broadband. This auction will affect the 600 MHz band and may extend down to the upper 500 MHz band as well. For wireless mic operators this means that many UHF TV channels used today may no longer be available to mics in the future. The Federal Communications Commission (FCC or “Commission”) recently announced their initial clearing target for the auction which indicates reallocation of UHF spectrum above 566 MHz (up to 698 MHz). This represents the maximum amount of spectrum that will potentially be repurposed.
